## 6. Non-Payment of Water Bill

Service will be suspended for unpaid bills.

Reconnection Fee: \$200.00

• Service will not be restored until full outstanding balance plus \$200 fee is paid.

## 7. Tampering and Damage

- Tampering / Lock Removal / Unauthorized Valve Operation: \$500.00 + Expenses
- Damage to District Property: \$500.00 per incident + Expenses
- Board may notify the authorities and seek prosecution.

### 8. Returned Check Fee

• Fee: \$35.00 per returned check

9. Request for Re-Read

• Fee: \$15.00 (If there is no error)

10. Late Fee

• Fee: \$10.00
